



# Payment

As per Condition 9.6 payment must be made in Euro for each lot on the day of sale unless credit arrangements have been agreed prior to bidding. Please direct all credit enquiries to **Liam Hanly** at Goffs before bidding.

All accounts are payable in Euro and Goffs are not responsible for any currency fluctuations or differential where payment is made in a foreign currency.

NB: Interest will be charged on late payments in accordance with the Conditions of Sale (Condition 10.5)

## Unpaid Accounts

## Cheque Payments

New purchasers wishing to pay for lots purchased by cheque should obtain a written reference from their bank for the maximum required and lodge it with Liam Hanly in the Sales Office prior to bidding.

## Cash Payments

Irish Law requires purchasers to provide proof of identity and address when making cash payments of €15,000 or more (or the sterling equivalent).

Goffs will require to take copies from the originals of the following documents:

1. Proof of identity – passport or photographic driving licence
2. Home address – an original utility bill, or bank or credit card statement dated within the last six months, showing your full name and full current address.

Copies of the above documentation will be retained on file by Goffs.

## Credit Card Payments

Payment for lots purchased may be made by credit and/or debit card (subject to acceptance of the type of card). Purchasers should contact the Sales Office regarding this type of payment and should inform the card provider prior to sale to avoid delays. Please note that all transactions must be authorized by a PIN number. Goffs regret that a surcharge of 2.0% for commercial cards and 1.75% for credit cards and 19c for debit cards will be added to the appropriate amount. These are the rates charged to Goffs by the credit card companies
