Qualification

For two year olds that were catalogued in the 2022 Orby Sale and have been declared by Goffs as eligible to run including:

- Horses sold under the hammer or privately at the sale through Goffs
- Horses not sold or bought back by the vendor will qualify if the sale entry fee and commission is paid, as per Condition of Sale 2.

- Horses catalogued but withdrawn from the Orby Sale will qualify if they are subsequently catalogued and sold or bought back at the Goffs Autumn Yearling Sale.
- Horses that are the subject of a cancelled sale will qualify if the sale entry fee and commission is paid, as per Condition of Sale 2.

Payment must be made to Goffs within the terms laid out in the Conditions of Sale and Goffs reserves the right to declare the lot ineligible for entry into the race.

Weights

Colts & Geldings 9st 5lb • Fillies 9st

Entry Fees

€10,000 to run (1% of the minimum prize fund) as follows:

- €4,000 nomination fee declared at the time of the sale (will be added to the Goffs invoice and is non-refundable once declared and paid. For horses not sold or bought back by the vendor the fee must be paid by 1st December 2022 to confirm eligibility)
- €6,000 via entry stages to Horse Racing Ireland
 - €1,000 to enter on 3rd May 2023
 - €2,000 extra if forfeit not declared by 19th July 2023
 - €3,000 extra if forfeit not declared by 19th September 2023.

Entries

Entries will be accepted in accordance with the full conditions of the race as published in the Irish Racing Calendar, and must be made to Horse Racing Ireland (or Weatherbys for UK entries, France Galop for French entries).

Naming

Naming applications must be received by HRI no later than 19th July 2023. If an

acceptable application has not been made by that date, the horse will be disqualified and removed from the race.

Maximum Runners

The 7 furlong limit at The Curragh is 30. Should it be necessary to reduce the declared runners to the maximum runners, or to such lesser number that the Stewards may decide, runners will be reduced by the elimination of those horses which have not run. If further elimination is required the field will be reduced by the elimination of the horses that, in the opinion of the IHRB Handicappers, have the lowest adjusted ratings (having regard to the applicable sex allowance). International performances will be taken into account. The latest date for calculation of ratings is 10am on Tuesday 19th September 2023. The entry and forfeit fees paid to HRI (totalling €6,000) will be refunded to any horse eliminated due to excess numbers declared.

These conditions are subject to alteration and Goffs reserves the right to change, amend or vary any detail, arrangement or condition in connection with this race at any time and without notice in their sole discretion. Furthermore Goffs shall not incur any liability for any loss, damage or expense in any circumstances and regardless of the parties involved or the consequential loss incurred by any party.

Group 1 Three-Year-Old Bonus

€100,000 will be paid by Goffs to the winning connections of the winner of the Goffs Million if that horse wins a Group/Grade 1 race in Australia, France, Ireland, UK or USA as a 3YO (first win only applies).

In the event of a dead heat in the Goffs Million and the two horses subsequently win an applicable G1 race the bonus will be split evenly.
