Qualification

For two year olds that were catalogued in the 2021 Sportsman's Sale and have been declared by Goffs as eligible to run including:

- Horses sold under the hammer or privately at the sale through Goffs
- Horses not sold or bought back by the vendor will qualify if the sale entry fee and full commission allowed in the Conditions of Sale is paid on the reserve price or Sale Price, whichever is the higher
- Horses catalogued but withdrawn from the Sportsman's Sale will qualify if they are subsequently catalogued and sold or bought back at the Goffs Autumn Yearling Sale.

Payment must be made to Goffs within the terms laid out in the Conditions of Sale and Goffs reserves the right to declare the lot ineligible for entry into the race.

Entry Fees

€1,000 to run (1% of the minimum prize fund) as follows:

- €400 nomination fee declared at the time of the sale (will be added to the Goffs invoice and is non-refundable once declared and paid. For horses not sold or bought back by the vendor the fee must be paid by 1st December to confirm eligibility)
- €600 via entry stages to Horse Racing Ireland
 - €100 to enter on 4th May 2022
 - €200 extra if forfeit not declared by 20th July 2022
 - €300 extra if forfeit not declared by 8th September 2022.

Entries

Entries will be accepted in accordance with the full conditions of the race as published in the Irish Racing Calendar, and must be made to Horse Racing Ireland (or Weatherbys for UK entries, France Galop for French entries).

Naming

Naming applications must be received by HRI no later than 20th July 2022. If an acceptable application has not been made by that date, the horse will be disqualified and removed from the race.

Maximum Runners

The 6 furlong limit at Naas is 24. Should it be necessary to reduce the declared runners to the maximum runners, or to such lesser number that the Stewards may decide, runners will be reduced by the elimination of those horses which have not run. If further elimination is required the field will be reduced by the elimination of the horses that, in the opinion of the IHRB Handicappers, have the lowest adjusted ratings (having regard to the applicable sex allowance). International performances will be taken into account. The latest date for calculation of ratings is 10am on Tuesday 8th September 2022. The entry and forfeit fees paid to HRI (totalling €600) will be refunded to any horse eliminated due to excess numbers declared.

These conditions are subject to alteration and Goffs reserves the right to change, amend or vary in any detail, arrangement or condition in connection with this race at any time and without notice in their sole discretion. Furthermore Goffs shall not incur any liability for any loss, damage or expense in any circumstances and regardless of the parties involved or the consequential loss incurred by any party.
